BACKGROUND

The commission established the Public Arts Subcommittee on February 9, 2023 and appointed Commissioners Allaman, Bahry, and Winward to the subcommittee. The subcommittee was formed after discussion from the commission on how to communicate the need for public art development as identified in the Folsom General Plan 2035 as well as the Folsom Plan Area Specific Plan.

Subcommittee Meeting #1

The subcommittee met on March 2, 2023 and established the purpose of the subcommittee, to educate and advocate for public art in public spaces for new development in Folsom.

They determined two objectives, 1) deliver education to city staff members, city commissions, community organizations, and city council; 2) advocate for the addition of public art as called out in the Folsom General Plan 2035 and Folsom Plan Area Specific Plan.



Updates:

• We are preparing a contract for GROW Development and Design to consult and develop a strategic plan for how to fund the Johnny Cash Trail Art Experience.

- Continuing the development of an operational agreement that would have the American River Natural History Association operate the Hinkle Creek Nature Center for nature programs and visitors. Should get ARNHA the agreement to begin review in the coming couple weeks.
- The "Festival of Eggs" was held on Saturday, April 8 for the 26th year at Lembi Park. Thousands of people joined in the fun that morning with big thanks to the community organizers: Folsom Athletic Association, Folsom Lake Lions, Folsom Kiwanis, Veterans of Foreign Wars, and Cappuccino Cruisers for all their involvement.
- The 9th annual Love My Mom 5K was held on Sunday, May 7 with nearly sold-out participation in for the Kids Dash and 5K run. This annual event celebrates mother's and is a great family gathering event with a tremendous partnership to the Folsom Parks & Recreation with the Palladio.



• The Folsom Parks & Recreation Department received an Award of Excellence from the California Park & Recreation Society for their 2021 Fun Factory Pre School video, "Are You Smarter than a Fun Factory Preschooler." Congratulations to Frankie Nelson and Sarah Valentine from our department for your work on this.



City Council Update:

- The City Manager presented the 2023-2024 Proposed Operating and Capital Budgets for the City of Folsom during the May 9 City Council Meeting. For more details on the city budget process, you can watch the previous council meeting and future council meetings.
- The new Parks & Recreation Director started on Monday, May 8 and was introduced at the May 9 City Council meeting. Kelly Gonzalez comes to the City of Folsom after serving as a division head for the Cosumnes Community Services District for the past 16 years in both the Administration and Parks and Recreation Departments. The Cosumnes CSD serves a population of over 200,000 residents in South Sacramento County and provides emergency medical service, fire protection, parks, and recreation services. Her senior leadership roles included Director of Administration, Director of Business and Public Affairs, Superintendent of Recreation and Community Services, Management Analyst, and Recreation Manager. Gonzalez's experience consists of facilitating the budget process, policy development, revenue generation, public affairs, facilities operations, program development, long-term planning, and building sustainable parks and recreation systems.
