SUBJECT: SELECTION OF CHAIRPERSON AND VICE-CHAIRPERSON

BACKGROUND

Section 4.05 of the Folsom Municipal Code (FMC) establishes the Park and Recreation Commission and identifies rules and regulations associated to the commission. Unlike other City of Folsom commissions and committees, Section 4.05 does not identify when the Chairperson and Vice-Chairperson are to be selected.

For example, Section 4.07.050 Officers of the Arts & Culture Commission states that, "the chairperson and vice-chairperson of the commission shall be elected every year by majority vote of the commission members. The chair and vice-chair may be replaced at any time by majority vote of the commission. No public hearing shall be required prior to the removal and no cause for removal need be shown."

Furthermore, in Section 16.56.050 Officers of the Landscape and Lighting District Advisory Committee states that, "the chairperson and the vice chairperson shall be elected by the committee every year by the first meeting in February by majority vote of the committee members. An officer can be replaced by majority vote of the committee at any time. No public hearing shall be required prior to removal of the officer and no cause for removal need be shown."

The duties of the Chairperson are to preside and preserve order at all regular and special meetings of the Commission. The Chairperson shall state every question coming before the Commission, announce the decisions of the Commission on all subjects and decide all questions of order without debate.

In the absence of the Chairperson, the Vice Chairperson shall perform the duties and obligations of the Chairperson.

The term of the office of the Chairperson and Vice Chairperson shall be one year.

DISCUSSION

The Park and Recreation Commission took action to select Chair Wallace and Vice-Chair Davidson at a meeting of the commission on January 19, 2023. In following other commissions and committees, it recommended that the Park and Recreation Commission elect a Chairperson and Vice-Chairperson to serve during the 2024 year with the term expiring at the first meeting of the commission in 2025.

RECOMMENDATION

It is the recommendation of staff that the Commission nominates and elect the positions of Chairperson and Vice Chairperson to serve until the first meeting of the commission in 2025.



DIRECTOR'S REPORT

A few highlights for the month of January

Highlights January City Council Meetings

January 9, 2024

- The City Council approved a resolution of commendation celebrating the Zoo Sanctuary's 60th Anniversary.
- The City Council approved the resolution authorizing staff to execute an agreement with Central Valley Engineering and Asphalt for the installation of the Johnny Cash Trail Cash Pick No. 1.
- The City Council authorized staff to proceed with an amendment to the existing contract agreement for the Maintenance of Parks, Trails, Pet Stations, and Streetscapes.
- City Council discussed the potential sales tax measure for the November 2024 election under two scenarios:
 - Add a General Sales Tax at the rate of 1.0% (tax can be used for any general governmental purposes and requires a simple majority voter approval – 50% plus 1)
 - Add a Special Sales Tax at the rate of 1.0% (tax is designated for specific governmental purposes and requires 2/3 voter approval)
- The City Council directed staff to come back in March with a one-cent sales tax and some wordsmithing on the special funding categories in the draft ballot language.

January 29, 2024

- City Council approved and recommended the North Alignment as the preferred alternative for the Folsom Boulevard Bicycle and Pedestrian Overcrossing Project and authorized staff to apply for grant funding through Caltrans Cycle 7 Active Transportation Program.
- Staff provided an update on the Placerville Sacramento Valley Railroad (PSVRR) License Agreement for Excursion Rail Operations with direction to staff. The City Council recommended to the JPA that the agreement be extended for seven years.

February City Council Meetings

February 13, 2024

- Staff will ask the City Council for direction on the Future Steam Train Operations at Folsom City Lions Park.
- There is a staff report recommending a resolution authorizing staff to submit a Grant Application for SACOGs Carbon Reduction Program for the Folsom Boulevard Bicycle and Pedestrian Overcrossing Project.
- The department will recommend to the City Council a resolution approving a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program.
- The City Manager and department heads will review department priorities during the FY 2024-2025 Preliminary Budget workshop.
- A presentation by the City Council for a Resolution of Commendation Honoring Leadership Folsom Class of 2022-23 for the 2023 Folsom Arts Achievement Award.


Staff began preparing for the February 13 budget workshop. Staff held a preliminary meeting with the budget subcommittee to discuss the upcoming budget cycle on February 2.

The City of Folsom adopted the Strategic Plan FY 2023-24 through FY 2027-28.

The Parks & Recreation Department is dedicated to supporting the goals and initiatives of the Strategic Plan. The goals identified by the City Council include Financial Stability, Public Safety and Infrastructure, Economic and Community Development, and Organization Effectiveness.

Goal A: Financial Stability and Sustainability

Support fiscal health through long-term planning, cost control, heightened efficiency, increased revenue, and cost recovery.

- The 2024 Community Sponsorship Packets have been sent out to potential partners.
- The following Community Partners confirmed their partnership with us for 2024: Folsom Lacrosse,
 Kaiser Permanente, Dokken Engineering, Financial Services, ActivityBees, and Broadstone Sports
 Club. Their sponsorship values are indicated in the report and will support the programs, services, and
 events offered.
- Staff have started the FY 2024-25 budget process, prioritizing requests, aligning initiatives with the strategic plan, and reallocating baseline budget funds.
- The budget and subcommittee held their first meeting of the year on February 2, where a FY 2024-25 budget development update was provided.
- The Folsom Athletic Association partnered with us, providing \$3,000 in sponsorship to free swim lessons for the upcoming season.

Goal B: Public Safety and Infrastructure

Enhance provision of public safety resources, invest in technological solutions, and maintain, repair, and improve public facilities and infrastructure.

- Construction of Prospector Park, the first park in the Folsom Plan Area, is well underway. This
 neighborhood park includes a play area, a field for soccer, rugby, and a Farmer's Market, a ball field,
 sports courts, a play area, and a dog park. Project completion is expected in fall 2024.
- The planning process for Benevento Family Park continues. The CEQA process was initiated and
 design development, which is a refinement of the master plan, is also underway. This new park in the
 Empire Ranch neighborhood will feature a children's play area, sand volleyball courts, and hillside play
 area. Project completion is expected in 2025.
- Staff completed the Folsom Blvd. Bicycle and Pedestrian Overcrossing Feasibility Study. The study included possible alternatives for establishing an east-west gap closure across Folsom Boulevard and the feasibility for its implementation. The city considered, through a public outreach process, a Class I multi-use overcrossing at a location between Blue Ravine Road and Glenn Drive to improve bicycle and pedestrian safety and access.
- Pick No. 1 is the first public art installment in the Johnny Cash Trail Art Experience. This construction project, which was awarded by the City Council January 9, includes decorative sandblasted concrete paving, installation of a concrete footing and sleeve for the sculpture, a 20' diameter cast iron "record deck" which is flush with the concrete paving, and miscellaneous site furnishings.
- Folsom Zoo Sanctuary Perimeter Fence project provides a new secure perimeter fence around the
 entire 6.7-acre zoo property. The fence meets U.S. Department of Agriculture (USDA) standards that
 are required to obtain a new operating license. This project was awarded by the City Council July 25,
 2023. Construction began in September and will be completed this February.
- The Livermore Community Park Phase 5A project includes a much-needed additional parking lot on McAdoo Street and provides trails and sidewalks. Design development and geotechnical investigation began in October 2023. Next steps include preparation of construction documents, engineering, and project specifications. Construction is anticipated to begin this fall.



Goal B: Public Safety and Infrastructure (continued)

- The Zoo Sanctuary is preparing for the USDA inspection in February. Staff have been busy with painting, welding, and electrical repairs.
- Parks Maintenance is inspecting the General Fund trails for long-standing maintenance issues such as damaged bollards, tree issues, signage, and site furnishings. Staff is also working to develop a Trail Management Program.
- Facilities Services is working to add additional electrical capacity at the zoo sanctuary in an effort to reduce the electrical load in existing electrical panels.
- Lembi Park restrooms have been added to our custodial contract agreement. This is an effort to provide a seven day/week schedule that has crews cleaning and securing the restrooms between 11 p.m. and 7 a.m. This change has decreased the amount of vandalism in this location.
- Staff are working to address park lighting repairs with Century Lighting to reduce outages. Major sports
 court lighting issues at Sheldon will be addressed in the first week of February.
- Interior painting was completed inside the Senior Center, Art Center, and Gallery at 48. New track lighting is being installed in the Community Art Gallery hallway as well as in the Gallery at 48.





Goal C: Economic and Community Development

Promote effective use of existing amenities and resources to create future opportunities that enrich the community.

- Staff presented January 18 at the Harris Center before the Johnny Cash: Official Concert Experience.
 Artist Adan Romo was also on hand to share updates and speak about the vision for the Johnny Cash
 Trail Art Experience. A Johnny Cash Trail display was set up in the lobby for guests to explore the art models, master plan, and purchase items for fundraising contributions to the Art Experience.
- Aquatics spring Sea Squad Swim School lessons are 100% full, with 132 participants registered.
 Registration opened January 8 for summer swim lessons; to date, 852 participants have enrolled.
- Wild Nights and Holiday Lights at the zoo sanctuary was a tremendous success with 18,831 guests generating over \$212,000 in revenue.
- The Meals on Wheels program returned to provide congregate lunchtime meal service at the Senior Center located at 48 Natoma. Meals are available three days a week on Monday, Tuesday, with 15 meals being served daily.
- The Folsom Youth Basketball Association (FYBA) provides youth in grades 1 through 12 the opportunity
 for recreation basketball in Folsom. Parks & Recreation staff facilitate the practice and game usage at
 eight elementary schools, two middle schools, and two high schools to meet the needs of over 12,800
 youth players Monday through Saturday.

Goal D: Organization Effectiveness

Build strong connections and support for the community and employees through a commitment to local government best practices and employee development, support, and retention to meet community needs.

- The Recreation and Community Services Division welcomed Jeremi DeOsio as the Recreation Coordinator II in sports following Martin Royston's retirement.
- Park Maintenance has spent the last few months developing a preventative maintenance management program. Staff have been working on the development of the asset management program and entering data into the software system.
- Staff from our Administration and Community & Cultural Services Divisions attended the 2024 Park
 Forum in January. The event featured a keynote presentation, and professional development sessions
 on updating RFPs, the importance of master plans, maintenance management plans, and much more.
- Sarah Valentine was selected for the CPRS District I Jane H. Adams Professional Development Grant Award. She will receive a scholarship for CPRS membership for the upcoming cycle.
- The Parks & Recreation Department is one of the largest employers of teens and several young adults in the City of Folsom. Applications are currently being accepted for various positions; details are available on the city website.
