#### 1. CALL TO ORDER:

The Arts and Culture Commission meeting was called to order at 6:31 p.m. with Chair Maribel Wyatt presiding.

### 5. BUSINESS FROM THE FLOOR:

Lorraine Poggione was present in chambers and spoke about the Folsom Takes Action initiative which is made up of citizens of Folsom to help address the revenue issues of the city. She spoke about the objective of the citizen's initiative and the current goal of obtaining the signatures required to get the tax initiative on the ballot. A brochure was provided for anyone who wanted to obtain more information about the initiative.

#### 6. SCHEDULED PRESENTATIONS:

#### A. Resolution of Commendation

A resolution of Commendation was presented to Cynthia Abraham. Chair Wyatt said kind words about Cynthia and her contributions over the last twenty-one years. The Resolution of Commendation was read aloud by Chair Wyatt. Cynthia's family was present in the chambers along with Sandy Hilton who hired her when she was hiring manager for the department.
