SUBJECT: TOBRURRY WAY SPEED ISSUES

### **BACKGROUND/ANALYSIS**

In September 2022, Public Works received a complaint from a concerned resident regarding speeding vehicles in the area. The complaint stated that,

"Thank you for the email response. The steps you provided are a good step forward. An example of signage which seems to work well is the bend along Barton Road as it becomes Santa Juanita Ave in Folsom. I realize that bend is almost 90 degrees, but you get the point.

As you may know, when school is out or on the weekends you will get the highest number of speeding vehicles in the area. Our house is located at 335 Tobrurry Way. The house which dealt with the speeding car which destroyed the trail barrier and flipped in the front yard is located at 360 Tobrurry Way. We often hear tires screeching at a high rate of speed.

If the city does not come up with a solution, the public trail located between our residences must be shutdown, out of fear of physical bodily harm. Adults, children and pets are all in danger at this bend, especially when they are trying to cross the road at dusk, dawn and night.

When should we expect the first phase of the plan you outlined? The neighborhood would greatly appreciate this to happen sooner than later. The problem gets worse every year."

Public Works utilized a consultant to perform volume and speeds counts over a 7-day period starting on October 18<sup>th</sup> and ending October 24<sup>th</sup>. A summary of the traffic counts is provided below.

Public Works analyzed the data collected from the consultant and did not find any abnormal numbers corresponding to a residential roadway. Volumes were extremely low and expected based on the roadway considered, speeds were within expected values with averages below the posted speed limit and 85<sup>th</sup> percentiles speeds at or below 30 MPH. Excessive speeding, or vehicles traveling at or above 10MPH over the posted speed limit in a residential street, were somewhere between 2 vehicles and 12 vehicles on a given day (0.45% - 4% of vehicles).

Between 360 Tobrurry Way and 336 Tobrurry Way, there is an unpaved path. This path continues on both sides of Tobrurry Way and has a textured pavement crossing. This crossing currently has no advanced signage or markings, and no ADA curb ramps.



#### STAFF RECOMMENDATION/TRAFFIC SAFETY COMMITTEE ACTION

Staff recommends that pedestrian crossing signage be placed at and in advance of the trail crossing location, and implement non-invasive education based traffic calming measures (Radar Feedback signs, and message boards) periodically and regularly.

SUBJECT: NATOMA STATION DRIVE/ASHCAT - SCHOOL SAFETY &

**NEIGHBORHOOD ISSUES** 

### **BACKGROUND/ANALYSIS**

On September 27<sup>th</sup>, Public Works performed a site visit with Natoma Station Elementary Principal, Vickie Boudouris, and School District Representative, Mike Hammond to discuss issues related to school pick up. The conversation focused on parking related issues along Ashcat Way, and more specifically, on the cul-de-sac of Ashcat Way where Vickie described parents double and triple parking and blocking driveway access to the 4 homes within the cul-de-sac. Other issues discussed were pedestrian crossing across the drop-off lane, vehicles maneuvering (U-turns midblock), and the intersection of Ashcat Way and Turn Pike Drive. One of the residents along Ashcat was able to take drone footage of a typical pickup period and can be seen at the link below

After the meeting, the Public Works Department installed pedestrian bollards at the intersection of Ashcat Way and Turn Pike Drive. After installation, we received a concerned citizens email "The issue is the four new this morning green standup crosswalk warning signs at the corner of Ashcat and Turnpike across from Natoma Station School. I'm curious about what problem is trying to be solved. It can't be speeding through the stop signs. That is an enforcement issue. People will now not stop just because of the crosswalk signs. Now, we have these four ugly signs that are the entry point to our community. I happen to live right across the street from it. It seems to me, that if people are breaking the law that a police car sitting there for a couple hours writing a half a dozen tickets would solve the issue. Now we have some environmental blight. I'm wondering what I might be able to do to alleviate this for myself, as well as a

couple neighbors who informally got together this morning and were equally concerned. I have a feeling this issue will grow just beyond the few of this morning."

SUBJECT: PARKSHORE DRIVE AND PLAZA DRIVE STOP SIGN REQUEST

## **BACKGROUND/ANALYSIS**

On July 7th, 2022, Public Works received an email from a concerned resident regarding a request for an all way stop sign at Parkshore Drive and Plaza Drive.

The City has evaluated conditions at this intersection many times, the latest was back in late 2017, the City hired consultant Kimley Horn to evaluate the intersection of Plaza Drive and Parkshore Drive for a potential all-way stop sign. It was concluded that all-way stop sign warrants were not met, but the restriction of parking adjacent to the intersection would improve the visibility of oncoming traffic. Subsequently in early 2019, City Staff installed "No Stopping Any Time" signs approximately 150' in each direction along Plaza Drive. During the period after the signs were installed, complaints from resident regarding compliance were received infrequently but persistently. City Staff then painted the curbs red to help increase compliance with the "No Stopping" signs.

Public Works conducted a volume and speed survey in July 2022 for the intersection to update the numbers from the 2017 analysis. Speeds were generally reasonable along Plaza Drive, with 97% traveling below 35 MPH. Accident history shows zero reported collisions within the past 3 years. Volumes along Plaza Drive average around 220 Westbound per hour for the 8 highest volume hours, and 370 for Eastbound. Combined these volumes meet the CAMUTCD threshold, however, Plaza Drive's volumes averaged 125 vehicles per hour during the same period, below the 200 vehicles per hour threshold set forth in the CAMUTCD for the minor street approach. Another consideration is that this intersection would be an optimal location for a future crosswalk to serve the pedestrian needs of the Farmhouse Community. Additional improvements (such as curb ramps and ADA landing pads) would need to be constructed to prior to striping the crosswalk(s), but Public Works would be able to include this work in its annual contract.

# STAFF RECOMMENDATION/TRAFFIC SAFETY COMMITTEE ACTION

Staff recommends that the Committee recommend to City Council that intersection of Parkshore Drive, and Plaza Drive be converted to an all way stop sign to accommodate pedestrian access and allow for parking restrictions to be removed adjacent to the intersection.

SUBJECT: CARPENTER HILL ROAD – SPEEDING ISSUE

## **BACKGROUND/ANALYSIS**

In June of 2022, during of the Parks and Recreation's public outreach of Benevento Park a number of complaints about existing speeding issues were reported to the Public Works Department and how the proposed driveway access on Carpenter Hill Road would increase traffic and speeding along Carpenter Hill Road. Specifically near the 90 degrees elbow near the northern end of Carpenter Hill Road between Owl Meadow Street and Fenceline Drive.

The project was taken to Parks and Recreation Commission on August 2<sup>nd</sup> 2022, and meeting minutes show that the Commission approve the Benevento Family Park Master Plan with the amendment with the following verbiage, "to continue to review potential traffic impacts and possible solutions to identify problems."

After the Commission meeting, Public Works requested a traffic count consultant to perform 2 separate data collection efforts. The first week of data collection was performed the week of August 20<sup>th</sup>, 2022, and the second set of data was collected beginning August 26<sup>th</sup> 2022.
