
#### **INFORMATION**

#### **Updates:**

• We are preparing a contract for GROW Development and Design to consult and develop a strategic plan for how to fund the Johnny Cash Trail Art Experience.

- Developing an operational agreement that would have the American River Natural History Association operate the Hinkle Creek Nature Center for nature programs and visitors.
- City Council conducted a Strategic Planning session on February 16. These were identified as their top priorities:
  - o Identify funding to increase police department staffing.
  - Identify a funding plan to expand police department facilities to meet department needs.
  - Initiate technology solutions to streamline organization and improve efficiencies.
  - Complete preparation of the River District Master Plan to enhance the City's waterfront and waterfront adjacent recreation and development opportunities.
  - o Develop funding/sponsorship plan for the Johnny Cash Trail Art Experience to increase tourism focused on Lake Natoma
- Saturday, April 8 from 8am-2pm will be the newly branded "Festival of Eggs" event held for the 26<sup>th</sup> year at Lembi Park. Come experience games and lots and lots of eggs.
