

3. MINUTES

4. <u>BUSINESS FROM THE FLOOR/GOOD OF THE ORDER</u>

The two following public comments were made. Bosch provided his card for a future follow-up with them.

Robert Calivas lives on Thomas Court near Ed Mitchell Park. He stated that the parking lot at Ed Mitchell Park is used frequently for school drop-offs. Additionally, he said that during school drop-off and pick-up times, there are a lot of problems with speed and people running stop signs. He asked for increased enforcement.

Rick Cogil spoke to bring attention to speeding that occurs on Willow Creek Drive. Specifically, the area right before the walking trail across from Shelly Court. He stated that rolling through stop signs and not seeing pedestrians in the crosswalks is also a problem.

5. <u>ACTION/DISCUSSION ITEMS</u>

Neighborhood Issues

a. Flower Drive Speeding Issues and Pedestrian Safety

Public comments were made by David Cornwell, Bruce Smith, and Rick Cole.

The Traffic Safety Committee recommends that the Public Works Department add both intersections of Flower Drive and Willow Creek Drive to the list for improved striping, painting 25 mph speed limit signs on Flower Drive, consider adding permanent radar feedback signs, installing additional 25 mph signs along the roadway, and trimming the existing trees that may block signage.

Bosch presented the staff report and answered questions from Committee members.

b. Traffic Safety Committee Action Item Updates

Bosch presented the staff report and spreadsheet. He pointed out items that have been added or that will be removed. He updated the committee on the status of the Rectangular Rapid Flashing Beacon installation at the different intersections that have been approved.

c. Upcoming Traffic Safety Committee Items

Bailey, Goddard, and Brausch proposed possible upcoming Traffic Safety Committee Meeting agenda items. Brausch printed a list of potential future agenda items that the committee discussed. Bosch and Galovich answered questions.

Galovich proposed the possibility of providing information regarding locations where the Police Department receives complaints and what they are doing about it for future meetings. He also gave an update on electronic scooter safety and enforcement efforts.

Bosch said the City will be modifying the intersection, on a trial basis, of Riley Street and Scott Street to allow for a right turn on red. Cameras will be installed at all signalized intersections in about a year as part of the ITS Master Plan Implementation Project funded by a SACOG grant.

The next meeting will be held on January 25, 2024.

SUBJECT: WILLOW CREEK DRIVE AT THOMAS COURT AND ED

MITCHELL PARK PEDESTRIAN SAFETY

BACKGROUND/ANALYSIS

In October 2023, the Traffic Safety Committee discussed the overall safety of Flower Drive. The concerns were focused into three main categories; perceived speeds in excess of the posted speed limit, proximity to schools and the interactions between motorists and children walking, biking, riding scooters, etc., and compliance with the stop sign at Flower Drive and Willow Creek Drive. The Traffic Safety Committee recommended the installation of pedestrian signage at both intersections of Willow Creek Drive and Flower Drive, which have since been installed, and the placement of pavement legends and radar feedback signs, which are still in the process of being installed.

During public comments and subsequently, through emails to city staff, residents introduced new concerns about pedestrian safety at and around the intersection of Willow Creek Drive , Thomas Court and Ed Mitchell Park, especially during peak school hours when many students and parents are walking along Willow Creek Drive and utilizing the Ed Mitchell Park parking lot to drop off and pick up the elementary school aged children.

Public Works staff performed numerous site visits during the AM peak and PM peak timeframe and found that the majority of motorists move and navigate the intersection of Willow Creek Drive, Thomas Court and Ed Mitchell Park entrance in a safe and reasonable manner. The parking lot was well utilized between 7:30 a.m. and 8:15 a.m. and there were also numerous children riding bikes, electric bikes, electric scooters, and other various modes of transportation cutting through the park to get to Blanche Sprentz Elementary School. City staff saw very few instances of unsafe behavior surrounding the intersections. Other observations included.

Crosswalks were unobstructed throughout the school drop off and pickup periods.

- A handful of vehicles parked directly adjacent to crosswalks, waiting for their children for up to 20 minutes.
- Numerous vehicles queued in the Ed Mitchell Park parking lot, along the parking spaces, and in the "No Parking" zones.
- Long queues in the Ed Mitchell Park parking lot caused vehicles to be trapped in parking spaces.
- The fire lane was completely obstructed for approximately 10 minutes due to queuing and parking in the "No Parking" zones.
- Spoke with parent picking up child who explained that the traffic is "bad for only a short time."

STAFF RECOMMENDATION/TRAFFIC SAFETY COMMITTEE ACTION

Public Works recommendation would be to enforce the existing parking restrictions as possible by the police department, install in street pedestrian signage at crosswalk on Willow Creek Drive at Thomas Court if determined feasible by City Staff.

SUBJECT: BARNHILL DRIVE AND SLUICE WAY TRAFFIC SAFETY

CONCERN

BACKGROUND/ANALYSIS

In May of 2023, the Traffic Safety Committee discussed traffic safety related issues near the intersection of Barnhill Drive and Sluice Way, where the curb is painted red. A resident within the Treehouse Community reached out to Public Works to report that "visitors and residents keep parking on the curve, blocking the view for drivers coming to the stop sign and not being able to see incoming traffic."

The Committee recommended action to replace the centerline dots around this curve and have the Police Department enforce the existing parking restrictions. Since then, residents in the area have experienced vehicles continuing to park within the restricted red curb area and have requested to expand the fire lane.


Currently, on Sluice Way, there is an unpainted 15-foot section of curb, allowing sufficient space for one car to park. The portion of the red curb on Barnhill Drive extends north from the intersection, approximately 25 feet. A sketch of the area has been provided as part of this report, showing the immediate vicinity where parking is restricted and the measured line of sight for southbound traveling traffic. It should be noted that while parking is highly utilized in the immediate vicinity, there are a number of spaces available within 400 feet to the west. The removal of the requested space would increase the line of sight from its current 70 feet to approximately 92 feet.


As with other neighborhood parking issues, Public Works Staff has posted signage in the area requesting feedback and comments from the surrounding neighborhood on this issue. Any comments received have been forwarded to the Committee and are available to the public.
