# <u>Meeting Minutes</u> City Council Regular Meeting April 10, 2018

City Attorney Steve Wang made a presentation and responded to questions from the City Council. Mr. Wang provided an overview of the ballot measures proposed to be submitted to the voters - sales tax revenue measure, term limits, and campaign contribution limits. He advised the City Council that placement of the revenue measure on the ballot requires a minimum of 4/5 vote of the City Council.

#### Revenue Measure

City Attorney Steve Wang made a presentation regarding the proposed revenue measure and responded to questions from the City Council. The City Council Members shared their comments and discussed the proposed measure.

The following speakers addressed the City Council:

- 1. Sally Howard, member of the Arts and Cultural Commission, expressed support of the revenue measure, and suggested an oversight body.
- 2. Marc Allaman, member of the Arts and Cultural Commission, expressed support of the revenue measure.
- 3. Whitney Yamamura, Folsom Lake College, expressed support of the revenue measure, noting he would like to have support for their educational programs and the Harris Center Performing Arts Center.
- 4. Paul Romero, member of the Parks and Recreation Commission, expressed support of the revenue measure, noting the aging parks system.
- 5. Sue Spielman, expressed support of the sales tax and letting the residents vote.
- 6. Peggy Plett, Friends of the Folsom Zoo, expressed support of the sales tax.
- 7. Dave Pier, Executive Director for Harris Center for the Arts, expressed support of the sales tax.
- 8. Joe Gagliardi, Chamber of Commerce, asked for time to survey the Chamber members.
- 9. Will Kempton, Chair of the Parks and Recreation Commission, expressed his support of the revenue measure.
- 10. Brian King, Chancellor of Los Rios Community College expressed support of the revenue measure, noting the importance of education and educational opportunities.
- 11. Barbara Leary, expressed support for the revenue measure and an oversight committee; noting that arts programs bring people to town.
- 12. Justin Raithel, member of the Planning Commission, expressed concern about the revenue measure being left as a general tax, sharing his desire to restrict its use to capital improvement projects.
- 13. YK Chalamcherla, member of the Parks and Recreation Commission, thanked the City Council for bringing the measure to the citizens of Folsom and expressed his support for the measure.

The City Council deliberated the proposed revenue measure. City Manager Evert Palmer and City Attorney Steve Wang responded to questions and provided additional information.

Motion by Mayor Steve Miklos, second by Council Member Andy Morin to approve revenue measure Ordinance No. 1283 and submit the revenue measure ordinance to the voters at the November 6, 2018 election.

## City Council Term Limits Measure

City Attorney Steve Wang made a presentation regarding the proposed term limits measure and responded to questions from the City Council. The City Council Members shared their comments and discussed the proposed term limit measure.

The following speakers addressed the City Council:

- 1. Tucker Hammerstrom, spoke against term limits and against having this placed on the ballot.
- 2. Russ Davis, spoke against term limits.
- 3. Martha Lofgren, former city attorney, posed questions about how certain situations such as a council member serving a partial term, would be handled. She suggested that perhaps a charter commission be convened to study and frame the measure.
- 4. Tom Aceituno, former city council member who served two terms, shared his thoughts on term limits and his support for the idea of a charter commission to review the measure.
- 5. Justin Raithel spoke against term limits, and in favor of any council member supporting term limits abide by those term limits immediately.
- 6. YK Chalamcherla, shared his thoughts on term limits.

The City Council deliberated the proposed term limit measure. City Manager Evert Palmer and City Attorney Steve Wang responded to questions and provided additional information.

Motion by Mayor Steve Miklos, second by Council Member Kerri Howell to continue the discussion of term limits to a future meeting.

City Manager Evert Palmer and City Attorney Steve Wang responded to questions and provided additional information.

Mayor Steve Miklos tabled his earlier motion and called a recess; the City Council took a break and the meeting reconvened.

# Mayor Steve Miklos withdrew his motion to continue the discussion of term limits.

City Manager Evert Palmer and City Attorney Steve Wang responded to questions and provided additional information.

Further deliberation of term limits was tabled until later in the meeting.

#### Campaign Contribution Limits Measure

City Attorney Steve Wang made a presentation regarding the proposed campaign contribution limits measure and responded to questions from the City Council. The City Council Members shared their comments and discussed the proposed measure.

The following speakers addressed the City Council:

- 1. Tom Aceituno, co-author of previous legislation; reviewed 1990 history; expressing support for increasing the limit, along with an "absolute reporting" requirement.
- 2. Barbara Leary, shared her thoughts that more people could run on a more level playing field if the amount could be increased to keep up with inflation with a built-in inflation escalator.
- 3. Justin Raithel, commented that independent expenditures give benefit to self-funding and shared his concern with a repeal of limits.
- 4. YK Chalamcherla, expressed support with increasing the amount in accordance with inflation to a minimum of \$250.

The City Council deliberated the proposed campaign contribution limit measure. City Manager Evert Palmer and City Attorney Steve Wang responded to questions and provided additional information.

Motion by Mayor Steve Miklos to set the limit at \$400. The motion died for lack of a second.

Motion by Council Member Andy Morin, second by Council Member Roger Gaylord to set the campaign contribution limit in the proposed ballot measure at \$500 (with the red-line amendment regarding "candidate-controlled" committee).

The City Council deliberated the proposed campaign contribution limit measure.

The City Council deliberated the term limits measure.

Council Member Roger Gaylord proposed the City Council consider four terms as the limit, with four years in between.

Mayor Steve Miklos withdrew his earlier motion to continue the discussion.

Motion by Mayor Steve Miklos, second by Council Member Roger Gaylord to set term limits in the proposed ballot measure as four consecutive terms, with four consecutive years as a break in service before being eligible to run again.
