CITY MANAGER REPORTS:

She advised that the City Council will consider this possible annexation, along with a workshop regarding the possible establishment of time limit parking within the Historic District residential areas at their October 23 meeting. Ms. Andersen invited residents to attend the Bark and Splash event, Fire Department Open House and Pancake Breakfast.

COUNCIL COMMENTS:

Council Member Roger Gaylord expressed his condolences to the families of Sacramento County Sheriff's Deputy Mark Stasyuk and expressed his deepest appreciation to all law enforcement.

Council Member Andy Morin spoke of the upcoming workshop regarding the possible annexation of transit services to Regional Transit. He shared his appreciation for the residents who contribute to Community Service Day.
