Joyce Roderick, spoke regarding the planning process for reuse of the corporation yard and the manner in which interested individuals can share their preferences for use of the property. At the Mayor's request, City Manager Evert Palmer provided information about the charrette. Mayor Steve Miklos reiterated that the charrette process was to start a baseline of a four to five year process to start vetting ideas and creating workshops to accumulate ideas and begin the planning. Vice Mayor Jeff Starsky commented that we will be having lots of meetings, noting that before anything can be done with the Corp Yard, a new site has to be identified.
