- Gary Richard, representing the Folsom Moose Lodge, Chair of Government Relations Committee, addressed the City Council regarding rumors that Vice Mayor Ernie Sheldon and city council candidate Jennifer Lane had made statements to the effect that, if she was elected, she may initiate an eminent domain action against the Moose Lodge to turn it into a parking structure with retail on the ground floor. Mr. Richard stated he and the Moose Lodge Members were opposed and expressed hope that the remainder of the Council members do not support the idea.

#### **CITY MANAGER REPORTS:**

City Manager Evert Palmer invited residents to attend the September 11 Memorial Service and to participate in the September 27 Drug and Alcohol Forum at Folsom High School and the October 25 Community Service Day.

#### **COUNCIL COMMENTS:**

Council Member Jeff Starsky noted that he had not heard the rumor about eminent domain proceeding impacting the Folsom Moose Lodge; he reminded the Moose organizations that it takes Council consensus to proceed with any action. He thanked the Moose organization for their good work.

Vice Mayor Ernie Sheldon thanked water department staff for their response to resident inquiries about watering schedules. He spoke of his recent experience renewing his driver's license at the Folsom DMV, complimenting DMV staff for the courteous service. Mr. Sheldon addressed comments made by Gary Richard under the "Business from the Floor" segment of tonight's meeting, stating that he has never advocated eminent domain proceedings for anything. He went on to say that no such remark was made; rather, the comment that was made was about the overall need for parking in the area and the suggestion that perhaps the City would be willing to give the Moose a new facility so they could move to a new location, given the need for repair work to be done to the Moose Lodge building and parking lot. In closing, Mr. Sheldon thanked the City Attorney for action taken regarding use of the residence at 916 Figueroa Street. He commented further on parking in the Historic District, suggesting that the parking problems remain because the four members on the Council other than him could have stopped the problems in 2008 but did not.

Council Member Steve Miklos spoke of recent SACOG action to recommend grant funding for the Johnny Cash Trail. Mr. Miklos thanked the Moose organization for their work, saying he hadn't heard the eminent domain rumor and that if repairs are needed, we should figure out how to help get those repairs done. He urged all involved in campaign activity to try and speak to facts (not rumors) about campaigns and past actions. Mr. Miklos, in response to comments made by Vice Mayor Sheldon about parking in the Historic District, reminded all that in 2008 Vice Mayor Sheldon spoke in opposition to permit parking; Mr. Miklos encouraged people to watch the video of that meeting. Mr. Miklos noted that the majority of historic district residents don't want a residential parking permit program. He returned to the subject of SACOG and their endorsement of awards for the area south of highway 50 for smart planning awards, including air quality and green growth accolades.

Council Member Andy Morin offered assurance to the Moose organization that eminent domain proceedings were not being pursued. He wished all seven candidates for the three City Council seats good luck. He spoke of upcoming homecoming events at the Folsom high schools.

Mayor Kerri Howell expressed regret that she will miss the September 11 Memorial Service, due to her attendance at a regional water authority meeting. She invited residents to attend the Mayor's Cup Golf Tournament, the Run For Courage event, and the October 3 performance by Rosanne Cash at Three Stages and the October 4 Johnny Cash Trail ribbon cutting. She offered congratulations to Folsom High football player Jake Browning, and in closing, reminded everyone to drive carefully.

## **ADJOURNMENT:**

There being no further business to come before the Folsom City Council, the meeting was adjourned at 7:01 p.m.
