Minutes

EWR Director's Report

- Staffing update:
 - o Engineering Technician: Michael Brewer started October 16th. He is working on mapping and pulling reports for both water and wastewater services.
 - o Meter Division Maintenance Worker: Sean Sargiotto started on November 1st.
 - Senior Office Assistant: Janine Hassell started November 18th, supporting the Utility Maintenance and Water Meter divisions at the Treatment Plant.
 - Wastewater Division Wastewater Tech: Interviews conducted today (November 19th) to fill three vacancies in the division. Hopefully new employees can be confirmed at the next meeting date in January.
- Next Meeting:
 - o No meeting in December, so the next meeting will be in January 2020.

Old Business

- Rate Study Update:
 - The Public Open House Workshop on November 6 was attended by approximately 25 people and lasted about 1 hour 20 minutes. Some used this as an opportunity to vent frustration about more general City matters, but there were also some more relevant questions about surcharges, the Rate Study process, and inclusion of potential future changes to the solid waste service.
 - As of November 18, 143 protests had been received in response to the Prop 18 notices.
 The deadline for submittal is the December 10th City Council meeting, with a total of approximately 12,000 required to stop the planned rate increases.

New Business

• Director Nugen provided a Presentation Regarding the Impacts of Residential Organics Recycling Mandated by Senate Bill 1383. This was the same presentation as made to City Council last week. Director Nugen summarized requirements of the law, along with potential impacts on City of Folsom solid waste service and associated costs. It was stressed that the regulations have not yet been finalized; there are currently many unknowns and therefore this could not be accounted for in the current Rate Study. It is anticipated that there will be a need to request additional rate changes within the next few years.

Director Nugen responded to questions from Commissioners, discussing the City's approach to legislation, the importance of educating the public, and methods of handling the enforcement aspect of the Bill in the most efficient way possible.

• Director Yasutake provided a presentation on Voluntary Agreements, focusing specifically on the American River Basin. There was discussion of water supply, groundwater and surface water storage options.

SUBJECT: 2019 WATER USE REPORT

BACKGROUND

On December 10, 2019, the Folsom City Council conducted a Public Hearing regarding rate increases for solid waste, water, and wastewater. Leading up to and during the Public Hearing, the City received the following number of protests for each utility:

- Water 201 (11,177 needed to have a majority protest)
- Wastewater 210 (12,264 needed to have a majority protest)
- Solid Waste 227 (12,264 needed to have a majority protest)

DISCUSSION

City Council approved the resolutions to increase rates for solid waste, water, and wastewater by a four to one vote. The new rates will go into effect on February 1, 2020.

SUBJECT: GOVERNOR NEWSOM'S WATER RESILIENCY PORTFOLIO

BACKGROUND

In April 2019, Governor Gavin Newsom issued an Executive Order N-10-19 directing various state agencies to develop a "water resiliency portfolio" for the state of California. The order identified the following seven principles:

- Prioritize multi-benefit approaches that meet several needs at once
- Utilize natural infrastructure such as forests and floodplains
- Embrace innovation and new technologies
- Encourage regional approaches among water users sharing watersheds
- Incorporate successful approaches from other parts of the world
- Integrate investments, policies, and programs across state government
- Strengthen partnerships with local, federal, and tribal governments, water agencies and irrigation districts, and other stakeholders

DISCUSSION

On December 3, 2020, the state agencies released the 2020 Water Resilience Portfolio. The state agencies include California Natural Resources Agency, the California Environmental Protection Agency, and the California Department of Food and Agriculture. The portfolio outlines over 100 integrated recommendations into the four broad areas listed below:

- Maintain and diversify water supplies
- Protect and enhance natural ecosystems
- Build connections
- Be prepared
