CASSELMAN/ARBUCKLE STOP SIGN REQUEST

#### **BACKGROUND/ANALYSIS**

The City of Folsom received a request from Courtney Hvostal (170 Arbuckle Avenue) to evaluate the intersection of Arbuckle Avenue and Casselman Street for a possible all-way stop sign.

The intersection is a tee-intersection of two residential streets, with stop control only on the minor leg (Casselman). Ms. Hvostal was able to obtain signatures from seventeen residents in the vicinity of the intersection (see attached map showing the location of the signatories). Staff noted that none of the residents located directly adjacent to the intersection were signatories, so a letter was sent out on September 18<sup>th</sup> to notify them of the pending request and offer them an opportunity express their support or opposition, either in writing or in person.

#### STAFF RECOMMENDATION/TRAFFIC SAFETY COMMITTEE ACTION

Staff recommends that the Committee approve the requested stop signs. If approved by the Committee, staff will forward the request to the City Council for final approval.







SPEED LIMIT ADOPTION: FOLSOM BOULEVARD, EAST

BIDWELL STREET, AND FOLSOM LAKE CROSSING

#### **BACKGROUND/ANALYSIS**

The City of Folsom is periodically required to review posted speed limits and conduct studies to determine if the posted limits are still valid. In cases where it is determined that the speed limit should be increased or decreased, staff is required to conduct a public hearing and obtain City Council approval in order to adopt the new limit.

Staff is currently conducting updated "Engineering Studies for Speed Zoning" on all major roadways throughout the City. The first two studies that were completed were Blue Ravine Road (from East Natoma Street to Folsom Boulevard) and Iron Point Road (from East Bidwell Street to Folsom Boulevard). Those speed surveys were adopted by the City Council in March 2019.

The next priority roadways are Folsom Boulevard (Greenback Lane to Highway 50), East Bidwell Street (Riley Street to Highway 50), and Folsom Lake Crossing (Folsom-Auburn Road to East Natoma Street); staff will present the updated speed survey data for these three roadways. There are no speed limit increases being recommended on any of the three streets; the only changes from current speed limits that are anticipated are as follows:

<u>East Bidwell Street</u>. The segment from Riley to Coloma does not have an adopted speed limit. Staff is recommending an adopted limit of 35 MPH – consistent with the adjacent segment of East Bidwell Street. The segment from Blue Ravine to Woodsmoke is currently 45 MPH, Staff is recommending an downward zoning to 40 MPH.

<u>Folsom Boulevard</u>. The segment between Blue Ravine Road and Highway 50 is recommended for a downward speed zoning from 55 MPH to 50 MPH.

Folsom Lake Crossing. The segment between Folsom-Auburn Road and East Natoma Street is currently posted 55 MPH and the consultant has been unable to come up with a valid speed survey to justify anything lower than that. The most recent survey does not even justify the use of radar to enforce a 55 MPH limit; after consultation with Folsom Police, staff is advising that the speed limit be left at 55 MPH and the Police will focus enforcement efforts on speeds that are in excess of the State maximum speed limit (65 MPH).

#### STAFF RECOMMENDATION/TRAFFIC SAFETY COMMITTEE ACTION
