BACKGROUND/ANALYSIS

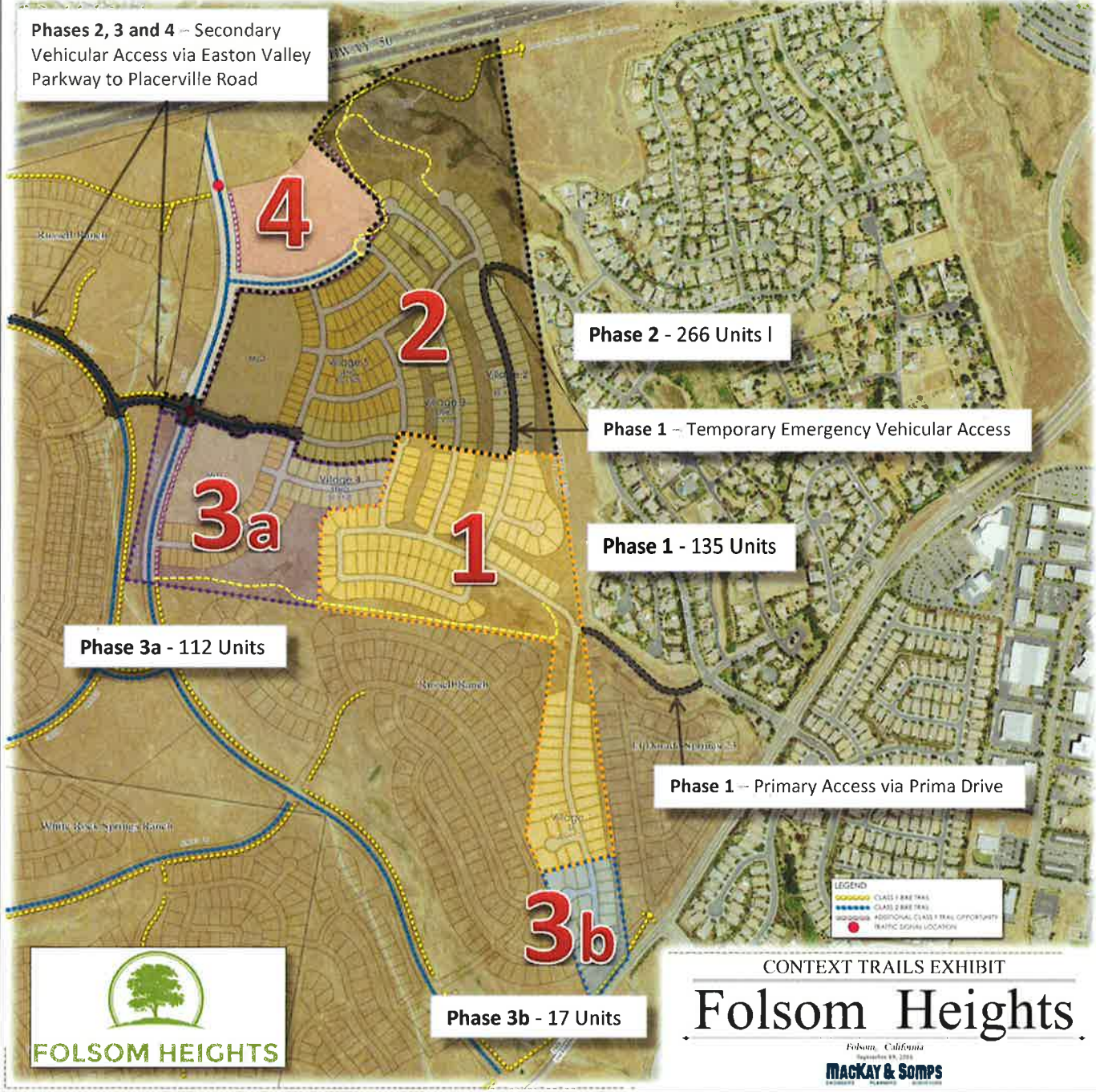
