

It was noted that this is still in draft stage due primarily to the impact of SB1383 regulations and the organics recycling mandate. Additionally, the department is in the early stages of a rate study, which it is anticipated will be available for the Utility Commission to review at August meeting, at the latest.
- Environmental and Water Resources Fiscal Year 2021-2022 Draft Operations and Maintenance Budget:

Director Yasutake presented detail of the Environmental and Water Resources Department's Operations and Maintenance budget, noting that the capital side of the budget will be presented at the next meeting. Director Yasutake responded to questions from the Commission.


PRELIMINARY OPERATING BUDGET

#### **DISCUSSION**




