

Directors' Reports

Director Yasutake provided an overview of the City budget process and how it is presented to the Commission over the first few months of the year, and invited Commissioners to reach out with any requests for specific topics for discussion during the coming year.

Director Yasutake also reported that there are currently three vacancies within the department.

Old Business

Solid Waste Rates Update:

Director Rackovan reported that the Solid Waste Rate adjustment was approved unanimously by City Council at the December 14th meeting, and new rates appeared on bills issued at the end of December. Council opted to waive the proposed fees for Household Hazardous Waste pick up and Bulky Waste pick-up. Department staff is evaluating the cost implications of suggested ways to assist low-income households with the billing changes.

Director Rackovan provided detail of steps the department is taking to implement the commercial organics and recycling mandates for businesses.

In response to a request, Director Rackovan agreed to provide the Commission with a line-item budget for solid waste services.

New Business

Fiscal Year 2020-21 Water and Wastewater Budget Recap:

Director Yasutake provided a presentation of the Fiscal Year 2020-2021 budget for the Environmental and Water Resources Department, covering detail of water and wastewater operations and capital improvement projects, and responses to questions from the Commission.






Calendar Year 2021 Water Use Presentation


Folsom Reservoir Precipitation

Snow Water Content







Stage 3 Drought Declaration




- Requires 20% reduction compared to 2020
