





- March 8 to 10-CPRS Conference in Sacramento. On March 8 from 2:00 to 3:15pm staff is hosting a tour group from the conference at Broader Family Homestead Park. Let us know if you'd like to join us.
- Hinkle Creek Nature Center-City staff virtually met with Hinkle Creek group (about 9 participants) on Monday, January 31 to provide an overview of staff efforts to activate the building and area as a "nature center". Staff is working on programming ideas, staffing, materials, and timelines. Budget requests for FY 22-23 are being submitted to support the efforts. Staff will provide a more detailed overview in the coming months after budget requests are approved.
- Our department is working on budget requests now to be submitted to City Manager/CFO in the next few weeks. They are reviewed and returned with comments and/or requests for additional information. The budget provided to us to begin with included full restoration of our O&M Budget (last year it was reduced by \$1,000,000; and full restoration of our Part-Time salaries (last year it was reduced by 50% from \$2,000,000 to \$1,000,000). This year we will be requesting

new maintenance staffing and respective resources for parks maintenance and municipal landscaping, an engineering technician and a full-time park planner to assist with CIPs and park planning functions. Funds for designing the next park in the FPA (#2) along with the approved CIP requests taken to Commission on January 25 (Benevento, Livermore Park, and Hinkle) will also be requested. Staff will provide more updates as we move through the budget process.

- Staff reviewed the 85% complete Design Development plans for Prospector Park and the approved concepts have evolved into implementable design plans that will go out to bid in a few months with construction to start later this year.
- Folsom Plan Area projections are looking good with a total of 3,600 residential lots expected to have building permits by July, 2022.
